


### **PROTECT CALIFORNIA'S AFTERSCHOOL SAFETY NET** Keep children learning and parents working

California has put students and families in our state's highest poverty communities at risk with years of inadequate and unsustainable afterschool funding.



California spends less than \$3 an hour for care for our most vulnerable students. That's less than the cost of a latte. Our students are worth more.



Since 2007, the state minimum wage has increased 62%, but state funding for After School Education & Safety (ASES) programs has only increased 18%

#### 86% of all California parents support public funding for afterschool programs.

To simply comply with the next state minimum wage increase, lawmakers need to allocate \$36 million to ASES programs. To backfill cuts made over a decade of underfunding, ASES programs need \$63 million more. In total, lawmakers need to increase funding for ASES programs by \$99 million in FY 2020-21 and bring the rate from \$8.88 to \$10.25 per child per day. ASES is one of the few categorical programs remaining outside of LCFF that does not receive a cost-ofliving adjustment (COLA). An annual COLA is needed to ensure a baseline of services for children and families as costs to operate grow.

### Investments in afterschool are investments in schools & the community

Research from the California Department of Education shows that afterschool programs bring an additional \$163 million to schools each year by improving school attendance for students involved. Additionally, according to the Afterschool Alliance, every \$1 invested in afterschool programs in California saves \$2-9 by increasing earning potential, improving academic achievement, and reducing juvenile crime. This modest budget request represents less than 1/7<sup>th</sup> of 1% of the total Prop. 98 K-12 education funding proposed for 2020-21.

# **AFTERSCHOOL WORKS**

## Afterschool programs help children succeed in school.

Regular participation in afterschool programs provides new learning opportunities and helps boost students' reading and math performance and grades.

### Afterschool programs support the whole child.

	Children living in poverty are 2-3 times more likely to be chronically absent.	Afterschool <b>reduces chronic absence</b> . Participants attend up to 17 more days of school compared to their peers.	More likely to stay in school and graduate.
